The 12th Restorative Justice Conference at Fresno Pacific University happens this month October 20-21. The theme is "Restorative Justice: Focus on the Victim" with featured speakers Dr. John Dussich, President, World Society of Victimology; Dr. Mario Gaboury, President, American Society of Victimology; Dr. Bernadette Muscat, California State University Fresno; and Dr. Arthur V.N. Wint, California State University Fresno. A wide variety of workshops will be available both days. This conference is an excellent place to learn about restorative justice and for our mediators to upgrade their skills. Restorative Discipline - Jill Shellenberg

Fresno Pacific University has implemented a restorative discipline system that is similar to VORP. The key difference is that EVERY case is sent through the Restorative Discipline System as opposed to only certain cases being referred to VORP by the Department of Probation. This systemic implementation has proved to be very effective with the result that many more cases are able to be handled informally. When a rule violation is filed, the victim and offender are informed about what mediation is. The parties are invited to choose whether they would like to proceed with mediation or take the case to a Student Judicial Board made up of students, staff and faculty. Students (both victim and offender) could then appeal to the Dean of Students if they didn't feel the ruling was fair, respectful and restorative.

Some of our goals in developing this new system were:

- Restoration of individuals
- Recognition of wrong
- Opportunity to make things right
- Restoration of community
- Opportunity for cooperative problem solving
- Creation of a structure that would promote student growth and mental, spiritual, and emotional development
- Victims need their feelings and interests addressed in every case. Just like VORP, the new discipline gives victims a voice that was often lacking in the old system.
- Offenders need to feel that the agreement was fair, respectful and restorative.
- The system brings the community into the process. Students are encouraged to bring their mentor, coach, favorite professor, parents, boyfriend/girlfriend, etc to the mediation.
- In a university system, the likelihood of victim/offender interaction is often unavoidable. When there are personal problems or rule violations on campus, students don't have the option of avoiding the offending party. People run into each other in class, at the library, in the cafeteria, at social and sports events, and so on. Having a way to deal constructively with the offense is a relief to

Restorative Discipline Continued...

So, now we've had one year of implementation and it is time to ask ourselves if the system is working. Because no other university that we are aware of has this type of system, it was difficult to predict what resources would be needed. We thought that probably about one third of the cases would go to the Student Judicial Board and two thirds would try mediation. To our surprise, all of the cases except one went to mediation. The longer the school year went on, the more cases were handled informally by the residence directors and assistants. Everyone became more familiar with mediation and used it as the preferred method of handling conflict on campus.

The Restorative Discipline System is helping to change the Fresno Pacific University culture.

Jill Schellenberg teaches Conflict Management and Statistics at Fresno Pacific University and had her first VORP training in the 1980's. She is working on her Victimology/Criminology Ph.D. dissertation in "Victim Recovery in a Restorative Justice Framework." Next month she will speak at a conference in British Columbia on "Conflict Management with Developmentally Disabled Children. She is happily married and has three adorable children.

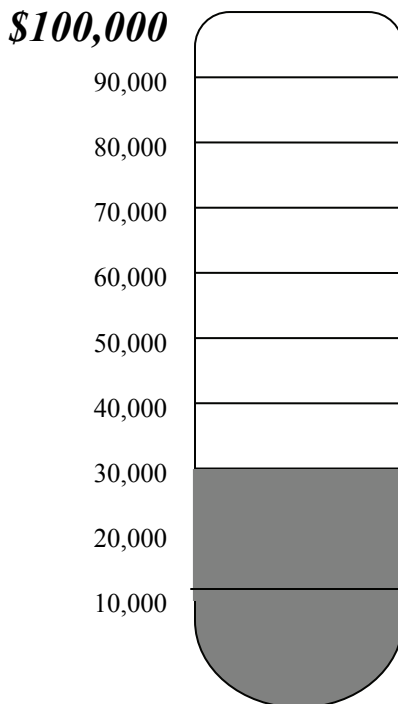
Mechelle Richardson
