between victim and offender went extremely well and were a big step forward in completing the process of reconciliation between victim and offender. The joint meeting turned out very well and both parties showed immense respect for one another. It was really amazing to watch the process of the victim and offender expressing their feelings towards one another. By watching the offender interact with the victim you could immediately see that it was not easy for the offender to express their wrongdoing. The victim was very open about expressing their feelings, but showed signs of nervousness too. After they talked for a while they got more comfortable and were able to

move forward and learn from the experience. The restitution they decided on was good for both parties and an agreement was made. VORP is a wonderful and unique organization. The reason why I love interning with them is because people are given a second chance, not only to better their own lives, but to also better their community. VORP also gives a chance for the victim to be heard and to receive restitution for their victimization. It has been a privilege interning with VORP and this first hand experience will only better my career in the future.
